

GRANTA SCHOOL COVID-19 GUIDANCE

HEALTH AND SAFETY PROCEDURES

Updated: 1st September 2021

INTRODUCTION

The school acknowledges the need to provide clear and specific guidance to all staff in order to ensure the safety of the entire school community during the ongoing Coronavirus pandemic. As the school provides a significant level of care for underprivileged children and young adults and those with special educational needs and disabilities, it is important to make all possible arrangements to resume education and supervision as soon as possible but to do so taking into account all necessary precautions as well as those recommended by the Government, Local Authority, Department for Education, Local and National Health Authorities.

The success of the arrangements will be subject to a significant amount of effort, cooperation and communication over a sustained period in circumstances that will likely be challenging.

This document has been prepared with the specific goal of ensuring the health, safety and well-being of all staff, pupils and visitors associated with the school. In the event that any of the arrangements or instructions are felt to be unclear or if clarification is needed, staff should not hesitate to contact a member of the Senior Leadership Team to highlight and discuss these issues.

RISK ASSESSMENT

A risk assessment has been prepared to identify the key hazards associated with operating the school during the pandemic. The risk assessment will be reviewed and updated on a regular basis in order to ensure the hazards associated with the lockdown being relaxed or otherwise are carefully assessed and working practices are amended as necessary.

This document has been prepared in order to make the arrangements for managing the risks on this basis as clear as possible for staff and will be formally communicated prior to work commencing.

In the event of two or more students/staff that have mixed closely testing positive, the school will move to the outbreak management plan (below), where bubbles and face coverings may be reintroduced dependent on Public Health advice.

INFORMATION, INSTRUCTION, TRAINING AND SUPERVISION

Prior to work commencing, all staff will be given all necessary information on what is required of them to ensure risks are managed and minimised throughout the working day. Many arrangements and practices that have been part of the daily routine will need to change and staff need to be given all necessary information to confirm what needs to change and why.

All staff will be given a copy of these procedures to allow them to read the arrangements and to raise questions or seek clarification from the Senior Leadership Team (SLT) about any matters that may be unclear.



Heads of Pathways will also communicate the information to staff on a regular basis and will ensure staff are reminded of the requirements and given appropriate assistance to implement them when challenges arise.

Risk Assessment: Coronavirus Outbreak

Introduction

This assessment is intended to allow for a regular assessment of the risk of a Coronavirus outbreak within the school or that may affect any pupil, visitor, parent or member of the public who may regularly interact with the school or those who attend.

The assessment process is reviewed at least weekly, or after any event that may give cause to reassess, in order to confirm the level of risk to the school and those who use it.

Examples of issues that may give cause for reassessment would include:

- Confirmed infection of an individual known to the school or in regular contact with school users
- A local infection or outbreak
- Visitors who have visited a country or area where an outbreak is confirmed
- A recommendation from a governmental or educational authority regarding an increased risk level
- Return after a term holiday

The level of risk should be reassessed frequently and the status of the risk level clearly communicated to those who may be affected or who are responsible for monitoring health.

Monitor the use of hand sanitiser with students to ensure it is not ingested.

Staff will encourage students to learn and practise good hygiene habits through games, songs and repetition.

Staff will model the use of "catch it, bin it, kill it" to students.

Keep windows open as much as possible to ensure good ventilation throughout the setting. Thought should also be given to thermal comfort e.g. use of higher level windows or opening windows when the room is not in use.

Identify any poorly ventilated areas and premises team to take steps to ventilate these as well as possible.

Plan to use outdoor space as often as possible during the day.

Regular cleaning procedures are in place across the site, particularly in communal areas and at touch points including:

- o Taps and washing facilities,
- o Toilet flush and seats, door locks, bins, sanitary bins, lavatory brush and toilet roll dispenser
- o Door handles and push plates
- o Handrails
- o Lift and hoist controls
- o Machinery and equipment controls
- o All areas used for eating must be thoroughly cleaned at the end of each break, including chairs, door handles
- o Telephone equipment
- Neyboards, photocopiers and other office equipment, tables and chairs

Where possible ensure surfaces are kept clear to enable cleaning.



If someone has tested positive with covid-19 then any area/room they have accessed will undergo a thorough clean; surfaces should be washed with hot soapy water, then sprayed with disinfectant and left for at least 60 seconds (or the manufacturers recommendations should be followed) prior to wiping. Care should be taken to ensure students cannot access the surfaces during this time.

Ensure that all staff are aware of the symptoms of Covid-19 and are alert to how to respond:

- o A high temperature this means the child feels hot to touch on their chest or back (you do not need to measure their temperature)
- A new, continuous cough this means coughing a lot for more than an hour, or 3 or more coughing episodes in 24 hours (if a child usually has a cough, it may be worse than usual)
- Loss or change to sense of smell or taste this means the child noticed they cannot smell or taste anything, or things smell or taste different to normal

Adults who are displaying symptoms should self-isolate and get a PCR test. A poster will be displayed at all entrances advising adults of this.


If a member of staff has tested positive using a home based Lateral Flow Device test they should book a polymerase chain reaction (PCR) test immediately to confirm the result and self-isolate until that result is available.

If a child or staff member develops symptoms compatible with coronavirus, they should rapidly be sent home and advised to get a PCR test. If the test is positive they should self-isolate for 10 full days from the day after their symptoms started. Their fellow household members will be advised to self-isolate for 10 days. All children and staff will be directed to the NHS Test and Trace portal if they display symptoms of

coronavirus to book a test and tracing of contacts to take place: https://www.nhs.uk/conditions/coronavirus-covid-19/testing-and- tracing/	
The isolation period includes the day the symptoms started and the next 10 full days.	
If any of the individual's household members are also present at the setting they will need to be sent home at the same time.	
The manager will support the family/staff member and ensure the outcome of the test in passed to the setting without delay.	
Any child displaying symptoms must be taken to the isolation room where they can be isolated whilst they are waiting for collection. A familiar adult, with appropriate PPE stays with them. This room is then thoroughly cleaned after use.

Guidance for Management of COVID-19 Cases in Education Settings from 16th August 2021

All settings need to have an "Outbreak Management Plan" in place to step up measures if required.

For any SUSPECTED or CONFIRMED case of COVID-19 in a staff member or child please follow the flow chart below

SUSPECTED case in child/young person or staff member who has COVID-19 symptoms

If the child/young person/staff is in the setting – isolate away from others and send home.

Clean and disinfect rooms the suspected case was using ensure appropriate PPE (gloves and an apron) are used.

Advise the parent/carer or staff member to book a PCR test as soon as possible online via the website www.nhs.uk/coronavirus.

Or by phone on NHS 119 for those without the internet.

Ensure child/young person/staff member isolates at home till test result. *The rest of the household does NOT NEED to isolate if they are:

- Under 18 and 6 /months or
- Double vaccinated or
- Part of a COVID Vaccine trial or
- Exempt for other reason

If none of the above apply then household contacts must isolate till test result.

Result of test (setting notified by parent/carer or staff member).

NEGATIVE

Child/young person/staff member can return to setting once well. Any household contacts can stop isolating.

Positive cases can return once the isolation period is completed if they are well. If they have diarrhoea or are being sick, they should continue to isolate until 48hrs after symptoms – as per usual sickness protocol. CONFIRMED case(s) in child/young person or staff member by EITHER:

Positive PCR Test or Positive LFD Test

Ensure child/young person/staff member isolates at home for 10 days. For symptomatic cases the first day of symptoms onset is DAY ZERO.

For asymptomatic cases the date of the test is DAY ZERO

*Their household/close contacts do NOT NEED to isolate if they are:

- Under 18 and 6 months or
- Doubled vaccinated or
- Part of a COVID vaccine trial or
- Exempt for other reasons

If none of the above apply, household contacts must isolate for 10 days.

If the <u>positive test was a LFD</u> advise the parent/carer/staff member to book a follow up PCR test <u>WITHIN 2 DAYS</u> of positive LFD. See close contacts info above to determine if any staff member is a close contact and should self isolate until the PCR result is known. Notify the Local Authority by completing the <u>short form</u>

CONTACT TRACING

- Any close contacts will be contacted by NHS Test and Trace.
- · Settings may be contacted by NHS Test and Trace to assist contact tracing.
- Any close contacts identified by NHS Test and Trace will be advised to get a PCR test as soon as possible (under 5s will only take a PCR test if it is a household contact), they do not need to isolate whilst waiting for the result unless they are symptomatic.
- Close contacts identified by NHS Test and Trace only need to isolate if they are over 18 & 6 months and have not been double vaccinated.
- If there is a positive case in a setting you do not need to notify parents/carers but you can do this using the template letters in the support pack
- If there is positive case in a member of staff ask staff close contacts to consider the following precautions if they are not required to self-isolate:
- limiting close contact with people outside their household, especially in enclosed spaces 2) wearing a face covering in enclosed spaces and where they are unable to maintain social distancing 3) limiting contact with anyone who is clinically extremely vulnerable.

Stepping up measures when the following thresholds have been met as per Contingency Framework <u>Click here</u>

- 5 or 10% (whichever is reached first) test-confirmed cases of Covid-19 within 10 days, among students or staff clustered in a consistent group or cohort, OR
- Evidence of severe illness e.g. students or staff members admitted to hospital or a death as a result of a COVID—19 infection

In these situations your Local Public Health Team will work with you to consider where transmission may be occurring and suggest introducing temporary measures to prevent further spread of the virus. You must therefore continue to keep accurate records of positive Covid-19 cases in staff and students. Granta COVID Outbreak Contingency Plan- September 2021

Should my child selfisolate or miss school?



- All children MUST attend school unless they are ill.
- From 16th August 2021, children under 18 (or double vaccinated adults) do not need to self-isolate if a member of their household or a contact has COVID.

Instead, they will need to book a PCR test but can continue coming to school so long as they have no symptoms and the test result is negative.



YES

- If your child develops COVID symptoms at home, they should <u>stay at home</u> and should book a PCR test, <u>NOT</u> a Lateral Flow Test.
- If your child develops COVID symptoms at school, they will be sent home and you should book them a PCR test.
- If your child tests positive for COVID, they will need to self-isolate.
 The rest of the household does not need to self-isolate if they are under 18 or fully vaccinated- but instead should book a PCR test.

The school will inform parents of any changes to COVID measures should these be needed.
